4) Daycare Subsidy

• Parents who qualify for Daycare Subsidy through Division of Family Services need to have full approval in place prior to attendance. Any fees not covered by DFS are the parents' responsibilities and are payable weekly. Proof of qualification needs to presented and kept on file prior to registration.

5) Pickup Policy/Overtime Rates

- Your child shall be picked up by 6:00pm. Any time after 6:00pm, you shall be charged a late fee of \$1.00 per minute.
- "Extended Hours": Any time past the 10-hour policy limit, you shall be charged an additional \$5.00 per day.

6) Illness Policy

- Children must be kept home when ill, as defined in the parent policy handbook (minimum of 48 hours). This will help protect the staff and other children in the center.
- If a child becomes ill while at St. Philip's ECC, a parent/guardian will be notified. You or an authorized person shall pick your child up within one hour. A penalty fee of \$5.00 shall be charged for every half hour past the one hour limit. This is to protect the health of the other students in the center.
